一、定义Definitions

个人信息: 以电子或者其他方式记录的与已识别或者可识别的自然人有关的各种信息,包括但不限 于姓名、出生日期、身份证件号码、个人生物识别信息、地址、电话、电子邮箱,但不包括匿名化 处理后的信息。

Personal Information: all kinds of information related to an identified or identifiable natural person recorded electronically or by other means, including but not limited to name, date of birth, ID card number, personal biometric information, address, telephone number and email, but excluding the information after anonymization.

敏感个人信息: 一旦泄露或者非法使用,容易导致自然人的人格尊严受到侵害或者人身、财产安全 受到危害的个人信息。一般而言,生物识别、宗教信仰、特定身份、医疗健康、金融账户、行踪轨 迹等信息,以及不满十四周岁未成年人的个人信息等被视为敏感个人信息。在本政策中,有关敏感 个人信息的条款将以加粗字体标注以提示您的特别注意。

Sensitive Personal Information: personal information that, once leaked or illegally used, may easily lead to the infringement of the personal dignity of a natural person or endanger the safety of person and property. In general, information such as biometrics, religious beliefs, specific identities, medical and health care, financial accounts and whereabouts, as well as the personal information of minors under the age of 14, are considered sensitive personal information. In this Policy, terms relating to sensitive personal information will be highlighted in bold to indicate your special attention.

If you leave a message to us through Focuslight platform, you need to provide your name, company, telephone, email, message subject and message content so that we can review your identity and handle your message.

We regard minors under the age of 14 as children. Focuslight services are targeted at the general public, not specifically designed for children or targeted at children. We will not deliberately collect, use or disseminate personal information of any child. When we know that we have collected the personal information of children, we will delete the relevant information.

You agree and accept that for the purpose of evaluating the creditability of our potential customers and to facilitate successful cooperation with such potential customers, including payment by contract, we will collect credit information from you;

三、我们如何保护您的个人信息

How to protect your personal information

我们只会在达成本政策所述目的所需的期限内保留您的个人信息,除非法律有强制的留存要求。如 果超过上述期限,我们将及时删除或对您的个人信息进行匿名化处理。

We will only retain your personal information for the period necessary to achieve the purpose stated in this Policy, unless there is a mandatory retention requirement by law. If the above time limit is exceeded, we will delete or anonymize your personal information in time.

我们采取符合业界标准的措施和技术手段存储及保护您的个人信息,防止个人信息丢失、被误用、 遭到未授权访问或泄漏、被篡改或毁坏。例如,使用受信赖的保护机制防止数据遭到恶意攻击,部 署访问控制机制以确保只有授权人员才可访问个人信息等。我们对可能接触到您的信息的员工也采 取了严格管理,尽力确保只有授权人员才可访问个人信息。

We take measures and technical means in line with industry standards to store and protect your personal information, and prevent the loss, misuse, unauthorized access or disclosure, tampering or destruction of your personal information. For example, use trusted protection mechanisms to prevent data from malicious attacks, and deploy access control mechanisms to ensure that only authorized personnel can access personal information. We have also adopted strict management on the personnel who may have access to your information, and try our best to ensure that only authorized personnel can access your information.

The transmission of data through the network cannot guarantee 100% security. Although we are committed to protecting your personal information, we cannot guarantee its absolute security. If a personal information security incident occurs, we will perform the relevant notification obligations according to the requirements of laws and regulations, including informing you of the basic situation and possible impact of the security incident, the response measures we have taken or will be taken, suggestions on self-protection and risk reduction, corrective measures, etc. We will promptly inform you of the relevant situation of the security incident through e-mail, fax, telephone, notification, etc. When it is difficult to inform the personal information subjects one by one, we will take a reasonable and effective way to publish the announcement. At the same time, we will actively report the disposal of personal information security incidents according to the requirements of regulatory authorities.

四、我们如何委托处理、共享、公开、转让您的个人信息

How do we entrust Processing, sharing, disclosing and transferring your personal information

1. 委托处理Entrust Processing

我们可能委托授权合作伙伴处理您的个人信息,以便授权合作伙伴代表我们为您提供某些服务或履行职能。我们仅会出于本政策所述目的委托其处理您的信息,授权合作伙伴只能基于必要性原则(need-to-know Principle)接触到其履行职责所需信息,且我们将会通过协议要求其不得将此信息用于其他任何超出委托范围的目的。如果授权合作伙伴将您的信息用于其他用途,其将单独征得您的同意。

We may authorize an authorized partner to process your personal information in order to authorize the partner to provide you with certain services or perform functions on our behalf. We will only entrust our partners based on need-to know principle to process your information for the purpose stated in this Policy. Authorized Partners will only have access to the information required by them to perform their duties, and we will require them by agreement not to use this information for any other purpose beyond the scope of the authorization. If authorized partners use your information for other purposes, they will seek your consent separately.

我们承诺对您的个人信息进行严格保密。除法律法规及监管部门另有规定外,我们不会将您的个人 信息共享给任何公司、组织和个人。如确需共享,我们会向您告知接收方的名称、联系方式、处理 目的、处理方式和个人信息的类型,并取得您的单独同意。

We promise to keep your personal information strictly confidential. Unless otherwise stipulated by laws, regulations and regulatory authorities, we will not share your personal information with any company, organization or individual. If sharing is necessary, we will inform you of the recipient's name, contact information, processing purpose, processing method and type of personal information, and obtain your individual consent.

We may share personal information or other information with our affiliates based on scenarios specified in this Policy. We will only share your personal information for lawful, legitimate, necessary, specific and explicit purposes, and will only share personal information that is necessary to provide the services. If we share your personal sensitive information or the recipient of shared information changes the use and processing purpose of personal information, we will seek your authorization and consent again.

When we may provide your personal information to any third party for any other reason not stated in this Policy, you will be notified and may request that we refrain from sharing such information.

3. 转让Transfering

than Focuslight, except as follows:

在涉及资产转让、收购、兼并、重组或破产清算时,如涉及个人信息转让,我们会向您告知有 关情况,并要求新的持有您个人信息的公司、组织继续受本政策的约束。如变更个人信息使用 目的,我们将要求该公司、组织重新取得您的同意。

In the case of asset transfer, acquisition, merger, reorganization or bankruptcy liquidation, if the transfer of personal information is involved, we will inform you of the relevant situation and require the new company or organization holding your personal information to continue to be bound by this Policy. If the purpose of using personal information is changed, we will require the company or organization to obtain your consent again.

4. 公开披露Publicly Disclosure

原则上我们不会将您的个人信息进行公开披露。如确需公开披露时,我们会向您告知公开披露的目的、披露信息的类型及可能涉及的敏感信息,并征得您的单独同意。

In principle, we will not disclose your personal information publicly. If public disclosure is necessary, we will inform you of the purpose of public disclosure, the type of information disclosed and sensitive information that may be involved, and obtain your separate consent.

当任何人可能违反我们的网站使用的条款与规定,或者可能损害或妨碍我们的权利、财产、我们的客户或可能被这些活动伤害的其他人时,如果我们有理由相信披露这些信息有助于确认、联系或对违规人员采取法律行为时,在这种特殊情况下,我们可能披露联系信息。

When anyone may violate our website and under the terms of use, or it may damage or interfere with our rights, property, our customer or may be hurt by these activities of the other person, if we have reason to believe that disclosure of such information to identify, contact or take legal action for violations personnel, in this particular case, we may disclose the contact information.

5. 其他Others

In accordance with relevant laws, regulations and national standards, we do not need to obtain your consent to share, transfer or publicly disclose your personal information under the following circumstances:

It is necessary to sign and perform the contract according to your requirements;

• 为我们履行法定义务所必需(包括向司法或执法部门提交您的个人信息);



Necessary for us to meet our statutory obligations (including the submission of your personal information to judicial or law enforcement authorities);

- 为应对突发公共卫生事件,或者紧急情况下为保护您或他人的生命健康和财产安全所必需; Necessary to respond to a public health emergency or to protect the life, health and property of you or others in an emergency;
- 为公共利益实施新闻报道、舆论监督等行为,在合理的范围内处理您的个人信息; Conduct news reporting, public opinion supervision and other acts for the public interest, and handle your personal information within a reasonable range;

五、您对个人信息的权利 Your rights to personal information

您可以通过以下方式查阅和管理您的信息,我们会在符合法律法规要求的情形下响应您的请求: You can access and manage your information in the following ways, and we will respond to your request in accordance with laws and regulations:

- 您有权查阅、更正和补充您的个人信息,获取您的个人信息副本,您可以通过第九部分的联系 方式联系我们,我们会在法律规定的时限内响应您的请求。
 - You have the right to access, correct and supplement your personal information and obtain a copy of your personal information. You can contact us through the contact information in Section 9 and we will respond to your request within the time limit stipulated by law.
- 2. 除业务功能所必需的个人信息外,您可以联系我们改变您授权同意的范围,当您收回同意后, 我们将不再处理相应的个人信息。但您收回同意的决定,不会影响此前基于您的授权而开展的 个人信息处理活动。
 - In addition to the personal information necessary for business functions, you can contact us to change the scope of your authorization consent. When you withdraw your consent, we will no longer process the corresponding personal information. However, your decision to withdraw consent will not affect the personal information processing activities carried out on the basis of your authorization.

We protect your right to request the deletion of personal information in accordance with the law, unless we are required by law or regulation to retain it for a certain period of time. For personal information that meets the following conditions for deletion, you can contact us to request deletion:

 - Our processing of your personal information violates applicable laws and administrative regulations;
- 未经您的同意,我们收集或使用了您的个人信息;
 - We collect or use your personal information without your consent;

 - Our processing of your personal information violates the agreement between us and you;
- 处理您个人信息的目的已实现、无法实现或者为实现处理目的不再必要(例如,您不再使用 我们的服务, 您已经注销您的账户等);
 - The purpose for which your personal information was processed has been achieved, cannot be achieved or is no longer necessary for the purpose of processing (e.g., you no longer use our services, you have logged out of your account, etc.);
- 我们不再向您提供我们的服务;
 - We no longer provide you with our services;
- 您已经撤回您对我们处理您个人信息的授权同意。
 - You have withdrawn your authorization consent to our processing of your personal information.
- 您可以联系我们注销您的账户,在您主动注销账户之后,我们将停止为您提供产品或服务,并 根据适用法律的要求删除或匿名化处理您的个人信息。
 - You may contact us to deactivate your account. After you voluntarily deactivate your account, we will stop providing you with products or services and delete or anonymize your personal information as required by applicable law.
- 在您行使上述权利时,我们可能会要求您进行身份验证,以保障您的帐号和信息安全。 When you exercise the above rights, we may require you to perform authentication to protect the security of your account and information.

六、您的个人信息如何在全球范围转移

How is your personal information transferred around the world

原则上,我们在中国境内收集和产生的您的个人信息将存储在中国境内,但出于我们全球运营需要,为境外关联公司的建设和管理,您的个人信息可能会被提供给炬光科技已开展业务或拟开展业务的国家/地区。

In principle, your personal information collected and generated by us in China will be stored in China, but your personal information may be provided to countries/regions where Fouslight has or intends to conduct business for the purpose of our global operations and for the construction and management of overseas affiliates.

尽管此类国家/地区可能设有不同的数据保护法,但我们会通过与境外的接收方签订数据跨境传输协议以确保您的个人信息得到在中国境内足够同等的保护。例如,我们将在提供前开展个人信息保护影响评估、通过签署协议等方式要求接收方严格依据协议约定处理个人信息、采用技术及管理措施切实履行数据安全保护义务等。

Although such countries/regions may have different data protection laws, we will ensure that your personal information is adequately and equally protected in China by signing cross-border data transmission agreements with overseas receiving parties. For example, we will conduct personal information protection impact assessment before providing, require the recipient to process personal information in strict accordance with the relevant agreement, and implement data security protection obligations through technology and management measures by signing agreements and other means.

七、Cookies声明 Cookies Statement

"cookie"是指存储在计算机硬盘上的一条信息,用于记录您的网站导航,以便当您重新访问该网站时,可以根据存储的上次访问信息为您提供量身定制的选项。通常,您可以通过更改浏览器设置来阻止接受cookies。

A "cookie" is a piece of information stored on your computer's hard drive that is used to record your website navigation so that when you revisit the site, you can be provided with options tailored to the information stored from your last visit. In general, you can prevent accepting cookies by changing your browser Settings.
