According to the requirements of IATF process, the relevant registration certificate will be issued following TÜV SÜD headquarters' approval, and the official certificate is anticipated to be released in 120 days.



IATF 16949 is a global quality management system standard for the automotive industry that incorporates ISO 9001 with additional automotive requirements. The first edition was published by the International Automotive Task Force (IATF) in 1999, aiming to coordinate different assessment and certification systems in the global automotive industry supply chain. It is the basic requirement for the supplier quality system in the modern auto parts supply chain. Focuslight's headquarter, Xi'an, and it's Dongguan base already obtained the IATF 16949 certificates certified by TÜV SÜD in July 2020 and July 2023, respectively.

In November 2024, Focuslight Shaoguan Base accepted the certification audit conducted by TÜV SÜD in accordance with the IATF16949 quality management system.
